

Station Matters Stratford – Prize Draw Terms & Conditions

1. THE PROMOTER

- 1.1 The promoter of this prize draw is: HS1 Limited of 5th Floor, Kings Place, 90 York Way, London, N1 9AG (“**HS1**”).

2. THE DRAW

- 2.1 The title of the prize draw is “Stratford Station Matters Customer Survey Monthly Prize Draw”.

3. HOW TO ENTER

- 3.1 The prize draw is free to enter and no purchase is necessary.
- 3.2 To enter the competition you must:
- (a) visit our website at: www.stationmatters.com and select Stratford International Station;
 - (b) complete the survey;
 - (c) tick the box to confirm you wish to enter the prize draw; and
 - (d) enter your contact information.
- 3.3 Only one entry per email is permitted. Previous winners of a prize draw are not eligible to win a further prize.
- 3.4 The prize draw will run on a monthly basis. Entries received from 00:01 on the first day of a calendar month until 23:59 on the last day of that calendar month (the “**Closing Date**”) will be entered in to the prize draw for that calendar month.
- 3.5 HS1 will **Not** accept:
- (a) responsibility for entries that are lost, mislaid, damaged or delayed in transit, regardless of cause, including, for example, as a result of any postal failure, equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind; or
 - (b) proof of posting or transmission as proof of receipt of entry to the prize draw.
- 3.6 By submitting an entry, you are acknowledging that you have read, accept and agree to be bound by these terms and conditions.
- 3.7 One entry will be chosen from all of the entries received in any one calendar month. The winner will be selected by random draw supervised by an independent person on the first working day after the Closing date of each calendar month (“**Draw Date**”) and will win the prize (as specified in condition 5.1).

- 3.8 By entering the prize draw, you hereby warrant that all information submitted by you in your entry is true, accurate and complete in every respect. HS1 reserves the right to verify any information contained in your entry and/or your eligibility to enter the prize draw.
- 3.9 HS1 reserve the right in its absolute discretion to disqualify any entrant if it has reasonable grounds to believe that an entrant has breached any of these terms and conditions, any applicable law. Each entrant acknowledges and agrees that any failure to comply with these terms and conditions could lead to HS1 disqualifying that person, without HS1 giving any reason for such disqualification or granting any opportunity for challenge.
- 3.10 In the event that a prize-winner is disqualified from the prize draw, HS1 will select an alternative prize-winner in the same manner as the original prize-winner and such selection will be subject to these terms and conditions.

4. ELIGIBILITY

- 4.1 The prize draw is only open to all residents in the UK aged 18 or over
- 4.2 Any person that :
- (a) is an employee of HS1 or its holding or subsidiary companies;
 - (b) is an employee of agents or suppliers of HS1 or its holding or subsidiary companies, who are professionally connected with the prize draw or its administration;
 - (c) works at Stratford International Station or any other stations owned or operated by HS1; or
 - (d) is a member of the immediate families or households of (a) , (b) or (c) above,
- is not eligible to enter the prize draw. HS1 reserves the right to disqualify any person that it knows is, or has reasonable grounds to believe is, ineligible for the prize draw as a result of this condition.
- 4.3 In entering the prize draw, you confirm that you are eligible to do so and eligible to claim the prize. HS1 may require you to provide proof that you are eligible to enter the prize draw.
- 4.4 HS1 will not accept entries that are:
- (a) automatically generated by computer;
 - (b) completed by third parties or in bulk;
 - (c) illegible, have been altered, reconstructed, forged or tampered with; or
 - (d) incomplete.
- 4.5 There is a limit of one entry per email in any one calendar month. In the event that HS1 discovers or has reasonable grounds to believe that the same person has made multiple entries, such person and any entries made by them shall be disqualified and, if such entrant has already been selected as a prize-winner, an alternative prize-winner will be selected in accordance with the process described above.

6. WINNER ANNOUNCEMENT

- 6.1 HS1 will contact the winner within 14 days of the Draw Date via email using the details provided at entry
- 6.2 The decision of HS1 regarding any aspect of this prize draw is final and no correspondence or discussion will be entered into.
- 6.3 HS1 will send the name and county of the winner to anyone who writes within 4 weeks after the Closing Date of that calendar month requesting details of the winner and who encloses a self-addressed envelope to the address set out in condition 1.1.

7. CLAIMING THE PRIZE

- 7.1 If you are the winner of the prize, you must claim the prize by replying within 14 days to the email sent to you by HS1 in connection with condition 6.1. In your reply you must tell us your contact details, including your name, telephone number, email and postal address.
- 7.2 HS1 will make all reasonable efforts to contact the winner. If the winner cannot be contacted or is not available, or has not claimed his/her prize within the time frame specified in condition 7.1 HS1 reserves the right to select an alternative winner in accordance with the process described above.
- 7.3 The prize will be sent to the winner by post using the details provided by you in accordance with condition 7.1, within 30 days of the Draw Date.
- 7.4 HS1 does not accept any responsibility if you are not able to take up the prize.
- 7.5 No prize will be awarded where any entrant has committed any form of misconduct (as determined by HS1 in its sole discretion).

8. LIMITATION OF LIABILITY
